MARCHE MADAGASCAR SELLER TERMS AND CONDITIONS

1. Introduction

1.1. Welcome to the Marche Madagascar Seller platform! These Terms and Conditions ("Terms") govern your use and access to our services, including our website, our applications, our buttons, and other tools. By registering as a seller on Marche Madagascar, you agree to comply with and be legally bound by these Terms.

2. Registration and Account Integrity

- 2.1. All information provided during registration must be accurate, complete, and up-to-date.
- 2.2. Sellers are responsible for maintaining the confidentiality of their account information, including password and all activities under their account.
- 2.3. Sellers shall immediately notify Marche Madagascar of any unauthorized use of their password or account.

3. Product Listings and Content

- 3.1. Sellers agree to list items in the correct category and provide accurate, complete, and non-misleading information.
- 3.2. Prohibited items, as determined by Marche Madagascar or Madagascar laws, shall not be listed.
- 3.3. All listings must be in compliance with applicable local and international laws, including copyright laws.

4. Pricing and Payments

- 4.1. Sellers are responsible for setting prices for their listed items and ensuring all listed prices are correct.
- 4.2. Marche Madagascar shall process payments on behalf of sellers and remit the funds to sellers after deducting applicable fees and charges.
- 4.3. All financial transactions are subject to review by Marche Madagascar. In case of suspicious activity, Marche Madagascar reserves the right to temporarily withhold payments.

5. Delivery, Returns, and Customer Service

5.1. Sellers are responsible for ensuring timely delivery of items sold.



- 5.2. Sellers must specify their return and refund policy. In the absence of a specified policy, Marche Madagascar's default return and refund policy will apply.
- 5.3. Sellers agree to provide prompt and efficient customer service to buyers and handle any disputes directly.

6. Ratings and Reviews

- 6.1. Buyers may rate and review sellers based on their experiences.
- 6.2. Sellers must not manipulate ratings or reviews or pressurize buyers for positive feedback.

12.1. Marche Madagascar reserves the right to modify these Terms at any time. Any changes will be effective immediately upon posting, and the continued use of the platform by sellers signifies their agreement to such modified Terms.

13.1. These Terms constitute the entire agreement between Marche Madagascar and the sellers.



13.2. If any provision of these Terms is found to be unlawful, void, or unenforceable, that provision will be deemed severable from these Terms and will not affect the validity and enforceability of the remaining provisions.
